- Treasurer's Report: \$18,673.57 in Checking, \$23,904.14 in Savings, for a total of \$42,577.71
- Meeting minutes and treasurer's reports submitted and accepted
- Prairie State Classic: Sandy Sessink and Amy Weiler are in communication concerning the
  new facility, Beyond Stable Farm, in Woodstock. There will be catering on-site but the catering
  also cannot be there for a couple of the sessions so they are working on something else for
  those times. The show committee will have a teleconference after the 1<sup>st</sup> of the year to discuss
  the new AMHA Star Rating program and USEF modifications as well as the show. Overall, the
  new facility will cost less than Ledges but the show committee will be charging more for stalls.
  The new facility is Beyond Stables Farm in Woodstock, IL.

#### AMHA Board of Director's Fourth Quarter Meeting

November 17, 2017



Below you will find highlights from the AMHA Board of Directors Fourth Quarter Meeting, which took place November 4, 2017, in Chicago, Illinois. Following are reports from the Eastern, Central, and Western Directors and AMHA President, Mari

Sanderson.

#### Fourth Quarter Board Highlights, Chicago, IL (11.4.17)

- \* The 2018 Budget was finalized and approved with a much larger expected profit margin than in previous years and provides for promising growth in the coming years ahead.
- \* Growth in registry transactions continues and processing at the home office continues to run smoothly following the software conversion this summer.
- \* The Directors Guide was updated and will be available via the website shortly.
- \* Updated Director Nomination forms were finalized and will also be available online when the new cycle begins on April 1, 2018.
- \* It was reported that the 2018 Membership renewals have been mailed and the ability to renew online via the new software was also available.
- \* The Breed Promotion Grant committee was selected and will be reviewing applications immediately following the January 15, 2018 deadline so that recipients can be announced at the February 2018 Annual Meeting and Convention.
- \* The Fall/Winter newsletter (THE NETWORK) has gone to print and will be mailed to all AMHA members (directly to those not subscribing to TMH and bundled with TMH to members who also subscribe).
- \* The 2018 Stallion Service auction proudly has 43 stallions participating and the catalogs will be bundled with the Nov/Dec issue of The Morgan Horse magazine.
- \* Discussion was held in regards to clarifying and simplifying the Champion Title program. The Board sent some thoughts back to the Disciplines Committee for further review in regards to this program.
- \* The following shows were selected as the 2018 AMHA Regional shows:

EASTERN: Citrus Cup; Southern States; New England Morgan; New York Morgan

CENTRAL: Gold Cup; Summer Daze; Jubilee

WESTERN: Far West at the New Country Classic: Morgan Medallion

- \* The 2018 Convention is coming along and the registration materials are available online and will be in the Fall/Winter version of THE NETWORK and the Nov./Dec. issue of The Morgan Horse magazine. The Convention is scheduled for Lexington, KY February 15-17. There is the opportunity to add on an "optional" Tour and Taste of Lexington bus trip on Wednesday, February 14. This will include a tour of and lunch at "The Castle." It will be limited to the first 50 people that submit their request and fee.
- \* In order to encourage more membership participation and involvement in the Governance process, the First Quarterly Board Meeting will be held on Friday morning of the Convention as a scheduled event to be followed by an open forum discussion.
- \* The 2019 Convention is scheduled for February 6-9 at the Hyatt Regency Hill Country Resort and Spa in San Antonio, TX.

- \* Three judges' schools were approved for the 2018 year. They include the following options: 1) In conjunction with the Annual Meeting and Convention in Lexington, KY (for Large R judges only), 2) In conjunction with the Carousel Horse Show, and 3) In conjunction with the Southern States Regional Morgan Horse Show. Additional information will be available soon from the AMHA office.
- \* The candidates for the 2018 Board of Directors election were announced. From the Eastern Region, Incumbent Karen Marlin and Steven Handy. From the Central Region, Incumbent Kris Breyer and Mary Westman. From the Western Region, Terri Sturm.

Ballots will be e-mailed to eligible members on or around December 28. Be sure that AMHA has your current, correct e-mail address on file before the list is submitted to the Ballot company on December 8th.

- \* The updated promotional booth materials have been delivered to the AMHA office and are ready to be unveiled at our upcoming events. They include a stand up banner and a table top banner as well as a new tablecloth, brochures, and other promotional handouts. They will make their debut at the Superior Sale November 16-18.
- \* The Calendar Project was extremely successful in that all months are sold out increasing AMHA revenue (after expenses) of approximately \$9,000. All TMH magazine subscribers will receive (FOR FREE) a copy of the calendar bundled with their Jan/Feb issue. After much conversation with previous calendar purchasers, it was determined to also order a select number for individual retail sale.
- \* The Morgan Horse magazine continues to excel with increased ad sales and revenue and has instituted a new, faster way to invoice clients following issue releases. The office has received many favorable comments regarding the new option to pay invoices "online."
- \* The software conversion that occurred in August has a few loose ends to iron out but operations in the office continue to improve. Several changes and upgrades have been made to the website (such as the extended pedigree report online registry/ability to pay invoices online/ability to purchase "premium" memberships online/etc.). However, please note that with limited staff hours, we still have a long way to go in the organization and development of this site. The conversion required all ID's and password's to be temporarily changed. If you are unable to log on, please call the office to quickly obtain your correct ID and Password. Do not create a new account. We appreciate your patience during this process.
- \* AMHA and USEF are finalizing the project that will allow AMHA membership (competing levels) to appear on the USEF's online search of membership cards. This will greatly assist the show secretaries so, PLEASE be sure to include your USEF number with your 2018 membership renewal (it is on the new forms and online as well).
- \* NEW in 2018 for PREMIUM members you will receive small red indicator stickers to place on your Registry work envelopes to ensure you receive your PREMIUM membership "expedited" registry service all year. Be sure to take advantage of this significant membership perk.
- \* Discussion regarding the GREAT SUCCESS of the Oct. 28 "Day of the Morgan" open barn day events was held and it was noted that another round was being held that same day as the meeting (Nov. 4). The Board was extremely grateful to all the participating barns AND to organizer Sandy Sessink for her countless hours of planning, promoting, and overall organization of the event. It could not have happened without her dedication and commitment.

The 2018 Quarterly Board Meetings are scheduled for the following dates and locations:

**First Quarter:** Feb. 16, 2018, in conjunction with the Annual Meeting and Convention being held in Lexington, Kentucky at the Hyatt Regency hotel.

Third Quarter: September 7 & 8, 2018, at the Denver Airport Marriott at Gateway Park in Aurora, CO

Fourth Quarter: November 9 & 10, 2018, at the Embassy Suites Dallas (DFW) Airport South in Irving, Texas





# How to Body Clip Like a Pro

Though it's often an essential part of good horse management, clipping can be a daunting task. But don't worry—come hair or high water, we've got you covered. Here is everything you need to know to body clip like a pro.

#### To Clip or Not to Clip?

That IS the question. Here are some things

to consider:

Do you work your horse in cold weather? If the answer is no, you probably don't need to clip.

Does your horse sweat when you work him in cold weather? If yes, clipping can decrease drying time and keep him from getting a chill.

Are you willing to blanket your horse? Blankets are a must for body clipped horses.

Does your horse live outside all winter? He might need his full hair coat to keep warm against the elements.

#### **Tips for Would-Be Body Clippers**

Ideally you should bathe your horse before clipping, but if temperatures won't allow, thorough grooming is key. Use a curry comb to loosen dirt and hair trapped in the coat, which can dull clipper blades.

Remember to slowly introduce the clippers to your horse, especially if he's new to the experience. Some horses may be wary of the sound and vibration clippers make. And ALWAYS keep the extension cord away from your horse's legs.

As you clip, adjust the direction of your clippers to follow the hair growth patterns, which will help to reduce clipper lines. Send your blades out for sharpening if you suspect they're dull. Sharp blades prevent hairs from being pulled during clipping, which can irritate your horse.

#### **Get to Know Your Blades**

You'll need to purchase or borrow a pair of body clippers and the appropriate blades before you begin. Smaller clippers meant for the face and legs just won't cut it (see what we did there?). Generally, body clipping is done with a #10 blade, but there are several different types of blades available.

#### #10 Wide Blade - 2.4mm or T84 Blade - 2.4mm

These two blades are ideal for body clipping because of their width. They also make it easy to touch up mistakes and lines afterward if needed. (Note: the T84 is specific to Andis brand clippers.)

#### #10 Blade - 1.5mm



Leaves hair shorter than T84 and 10 Wide blades, but can be used for body clipping areas where wide blades will not work, such as the head and lower legs.

#### #15 - 1.2mm and #30 - 0.5mm

Leaves hair shorter (and shorter still!) than a #10 blade. Generally these blades are too short to use for general body clipping, but work well for specific areas such as the muzzle and bridlepath.



## **Clipping Styles**

#### **Full Clip**

The entire body is clipped, including the face, legs, and belly. This clip is appropriate for horses in heavy work during the winter and who will be turned out in dry areas.



#### **Hunter Clip**

The body and face are clipped, but the legs and saddle area are left unclipped. This clip is appropriate for horses in medium to heavy work.



#### **Blanket Clip**

The body and face are clipped, but the legs and area that a quarter sheet would cover are left unclipped. This clip is appropriate for horses in medium work.



#### **Trace Clip**

The underside of the neck, chest, belly, and halfway up the sides and hind end are clipped. This clip is appropriate for horses in light to medium work.

#### **Irish Clip**

The underside of the neck, chest, and belly are clipped; the upper clip line sweeps diagonally from the upper jaw line to under the flank. This clip is appropriate for horses in light to medium work.



# Bib Clip

#### **Bib/Strip Clip**

The underside of the neck, chest and belly are clipped. These clips leave the most hair on your horse and are appropriate for horses in light work.

#### **Aftercare**

Remember: depending on where you live, the more hair you remove from your horse, the heavier the blankets he'll require. Horses with full body clips need to be blanketed at

all times, and may require neck covers. Horses with more moderate clips may be able to get away with lighter layers depending on the climate and how much hair was removed. When riding a horse with fully clipped hind quarters, it is often a good idea to use a quarter sheet.
